Your Cintas representative can check your medical box monthly (or whatever your facility has scheduled)

Only the items listed on this contract can be replenished via this contract.

The Cintas Representative/your contact will complete the "Order Form" for the items that need replenished for the month.

The total of the "Order Form" must match the total of the "Invoice" by Cintas. If not, do not pay invoice.

Once the total of the "Order Form" & Invoice match, then request the PO from your contact person.

The contact person will request the ADO (PO) from Procurement.

The ADO (PO) will need to be attached with your paperwork (p-card payment) to complete your transaction.

NO ITEMS ARE TO BE PAID IF THEY ARE NOT LISTED IN THESE 26 ITEMS. THESE ARE OSHA REQUIRED ITEMS ONLY.

If you need additional items not on this contract, they are to be procured on a different transaction.
