If something isn't in stock, other accommodations can be made if necessary by accepting substitutions. Call Purchasing to discuss the options listed below:

- 1. We can wait for the shoes to come in – only if time will allow.**
- 2. Do a change order to cancel any contract shoes that are on back order. Then, re-order those shoes with a substitute type of shoe not on contract.**
- 3. If the shoe substituted is NOT on contract, it won't match the invoice. The invoice must match the PO in OASIS. If the line item is not on the Agency Master Agreement, then it can't be matched up and paid in the system.**
- 4. All substitutions *should be* offered at the same contract price we were originally offered.**
- 5. The “or equal” means that you can move to a different version of the Under Armour Infinite Pros or Charge Asserts 10 (or equal) that is like the style we listed, but you can't move to a different brand (Nike, Adidas, New Balance), for example.**
