NATURE AND SCOPE OF WORK:

Under general supervision of the Heavy Equipment Operator Course (HEOC) Program Manager, this position instructs and evaluates students enrolled in the HEOC in the proper techniques of heavy equipment operation in accordance with an approved Program of Instruction (POI). The HEOC is conducted at the Camp Dawson Training and Event Center, 1001 Army Road, Kingwood, WV 26537 with additional program activities conducted at the Nathan Goff Armory, 5 Armory Road, Clarksburg, WV 26301.

EXAMPLES OF WORK:

- 1. Coordinates with program staff in the implementation of the HEOC training calendar
- 2. Creates, prepares, and delivers daily lesson plans and course instruction in accordance with the approved HEOC POI
- 3. Delivers individual and collective instruction
- 4. Provides oral and written feedback
- 5. Administers verbal and written exams
- 6. Creates and maintains student records
- 7. Measures student proficiency by developing and administering assessments
- 8. Validates and records student achievement

- 9. Develops, demonstrates, instructs and supervises student engineering projects
- 10. Demonstrates, instructs and supervises proper maintenance and operation of heavy equipment, such as bulldozers, road graders, boom mowers, hydraulic excavators/Hyex, rollers, scrapers, dump trucks and compactors
- 11. Demonstrates, instructs and supervises the proper interpretation of grade stakes
- 12. Demonstrates, instructs and supervises the utilization of critical path methods
- 13. Demonstrates, instructs and supervises the utilization of proper route reconnaissance
- 14. Demonstrates, instructs and supervises clearing, grubbing, stripping, excavating, backfilling, stockpiling, and hauling, including the construction of embankments and ditches, excavation of hills and slopes, mixing soil stabilization materials, performing surface and drainage maintenance, and other activities utilized in conjunction with heavy equipment operation
- 15. Assists program staff with the procurement, transportation, movement, staging, and maintenance of required course equipment
- 16. Responsible for program equipment and property
- 17. Ensures students meet HEOC program expectations regarding personal behavior and appearance
- 18. Provides general supervision of students while participating in the HEOC
- 19. Responsible for the health, welfare and safety of students
- 20. Available for occasional travel to attend/facilitate off-site training
- 21. Performs other duties as assigned

KNOWLEDGE, SKILLS, AND ABILITIES:

- 1. Ability to communicate both orally and written
- 2. Ability to effectively instruct subject matter
- 3. Ability to safely operate tools and equipment used in equipment maintenance
- 4. Ability to perform physically arduous tasks
- 5. Ability to lift at least 50 pounds
- 6. Knowledge of engineering projects
- 7. Knowledge of heavy equipment operation
- 8. Knowledge of proper construction technique

TRAINING AND EXPERIENCE:

Training: High School Diploma or GED.

Experience: Two years of general teaching experience

<u>Substitute</u>: Work experience within a related skilled trade may be substituted for the required general experience on a year-for-year basis.

<u>Preference:</u> Preference will be given to those applicants who have (1) a career and technical education teaching certification; (2) industry recognized certification/training within the building and construction trades; and (3) served in the armed forces.
